


4-H Mascot


March

2023 Hall of Fame Inductee -

Harvey Welter

Harvey has been an active participant with 4-H since 1982, wherein he has held several positions, such as being a General Leader, mentor, volunteer, and judge for various events and projects. In the fall of 1982, Harvey became the General Leader of the Viscount 4-H Beef Club, where he held the position for 15 years. During those 15 years, Harvey was an intricate member in developing and maintaining the club's stability, while also ensuring club members felt supported and confident in any projects they tackled. Harvey is an embodiment of the motto "Learn to do by doing" by welcoming calls from youth to share in his vast knowledge and experiences as a positive, respectful, and involved role model.



Nonetheless, after retiring as the General Leader for Viscount 4-H Beef Club, he and his wife, Cindy, continued to be supportive members by attending numerous activities the club hosted, including Achievement Day and steak nights. While in attendance for any function hosted by the club, Harvey offers words of encouragement and appreciation for the members, as well as towards the leaders for the work they have accomplished in continuing to make the club successful.

Although Harvey was a General Leader for 15 years, he also dedicated his time to other 4-H projects, including the Prairieland Junior Ag Showcase, in which he volunteered his time to be on the Steer Sale committee. While in his committee role, Harvey employed his strong moral compass and belief in the 4-H program to ensure successful sales for the members, clubs, and buyers, while also giving all parties involved recognition for their efforts.

Throughout the 40 years with 4-H, Harvey has been an intricate part on both the local and regional levels. In following the learn to do by doing mantra, Harvey is always willing to share his knowledge and expertise in a positive and enthusiastic way with anyone who may have questions regarding livestock marketing.

From there, in 1956 Thelma became what she describes it as MSH - mere summer help with the 4-H Homecraft Program. A year later, after she had graduated from Home Economics at the University of Saskatchewan, Thelma became a staff member with the 4-H Homecraft Program. In 1958 Thelma was appointed supervisor of the 4-H Homecraft program until the program united with the Agriculture 4-H program, at which time she still played an active roll in 4-H, rotating with her colleagues to be the Saskatchewan 4-H Club Supervisor. During this time, Thelma helped to introduce multiple project clubs, which resulted in expanding the scope of projects beyond the traditional projects.

Thelma's personal 4-H Saskatchewan highlights consist of playing an intricate role in developing the 4-H camping program, which led to Camp Rayner and helping to develop the Saskatchewan 4-H Foundation. Thelma has had other notable accomplishments throughout her life including working abroad to introduce community development programs related to women's role in agriculture, being the secretary and University representative for the Saskatchewan 4-H Council, and just recently in 2012, Thelma was an inductee into the Saskatchewan Agricultural Hall of Fame.

Thelma is proud of all her achievements, however, she is most fond of "working with a great staff, great leaders, and great members."



Tracy Fitzsimmons

Tracy Fitzsimmons has been an active member with 4-H through various roles, most notably as a member, parent, leader, volunteer, and board member with the board of directors. 2023 4-H Saskatchewan – Financial Statement Highlights

Dear members of the Saskatchewan 4-H Council,

This letter has been prepared to accompany our financial statements and highlight some of the factors impacting our 2023 finances.

As you review the financial statement, please note these key highlights:

- The Saskatchewan 4-H Council ended the 2023 year with a surplus of \$39,673.00.
- The 4-H Saskatchewan provincial office reduced the staff complement by 20% in 2023.
- Board of Director meetings have also been limited to one day and one meeting each year is held online.

The changes, along with a number of smaller adjustments, have moved the organization to a surplus position for 2023.

The 4-H Council Board and management will continue to look for ways to improve our financial sustainability. In the current inflationary environment finding efficiencies is the best way to avoid passing increased costs on to the membership. Your Board of Directors will continue to monitor the situation to ensure 4-H Saskatchewan remains financially stable for the years to come.

We look forward to formally presenting the statements in person when we come together at the 2024 Annual General Meeting and answering any questions you may have.
