## Ways to support the Saskatchewan 4-H Foundation:

### Gifts of Cash

Includes cash, cheque, debit or visa

### Gifts of Securities

Includes stocks, bonds, or mutual funds

### Gifts of Real Estate or Other Assets

Includes real estate, art, or other assets

### Gifts of Residual Interest

When donating real estate, for example, you can retain the use of the property for life with a gift of residual interest.

### Gifts of Life Insurance

A gift of life insurance can make a large impact at a modest cost and can have various tax benefits both presently and in the future depending on how your policy is set up.

### In Memoriam Tribute

Recognize someone who has passed away with a memorial donation

### Donor Designated Funds

Your gift can be in the form of cash, real estate, appreciated stock, or other assets and will be placed in an endowed fund, carefully invested to grow over time.

The minimum amount to create a named, donor designated fund is \$25,000

# SCHOLARSHIPS

## Ways to support the Saskatchewan 4-H Foundation:

### Entrepreneurial Scholarship

Through the generosity and insight of Mr. William (Bill) Cooper, P.Ag., 3 scholarships valued at \$3,000 each are available to current or past 4-H members

### Brandt Equipment Scholarship for 4-H Members

Offers 5 scholarships of \$1,500 to students entering their first or second year of an agriculture-related degree, diploma, certificate or trade program.

### Holland Family Scholarship

Applicants must be entering the second or subsequent year of their program. They also must be enrolled in agriculture, agri-business or a related profession/trade. This scholarship has 2 awards valued at \$2,000.

### Gordon & Eileen Bonnor Scholarship Fund

This Scholarship Fund was created by Gordon & Eileen Bonnor in 2015. A scholarship valued at \$1,000 is provided for a student entering a Saskatchewan Agriculture University Degree program related to agriculture or agribusiness.

### Future Leader Scholarship

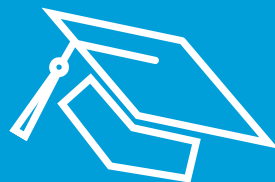
Offers a \$1000 scholarship to a student, entering first or second year of a post-secondary degree or diploma program, who demonstrates the knowledge and leadership skills gained from the 4-H experience as the key component of their career choices

### The McConaghy Scholarship

Two \$500 scholarships provided by the McConaghy Family for a current 4-H member entering a Business, Economics, Agriculture degree program at the University of Regina or University of Saskatchewan.

### AGI Agriculture Scholarship

The AGI Agriculture Scholarship; offering five \$1,000 awards.



### Palliser Insurance 4-H Scholarship

Two \$500 scholarships are available to 4-H members entering any degree/diploma/certificate program. Applicants must be a registered Saskatchewan 4-H member for the last two (2) years.

### South Country Equipment Scholarship

This scholarship is an excellent way to combine support for education with support for the youth in the communities we serve, and continue our legacy of supporting 4-H in Saskatchewan.

### Saskatchewan Polytechnic Veterinary Technology Diploma

### The Western Producer Scholarship

One award valued at \$1,000. We believe that encouraging and supporting the next generation of agricultural leaders is important to the future of the industry.

### The Saskatchewan Cattleman's Association (SCA) Scholarship

This scholarship was created to provide a \$1,000 award to an active 4-H member who aims for a career in the beef cattle industry.

### Hector Loveridge Memorial Scholarship

One award valued at \$1,000 created by the Loveridge family and managed by SCF.
