



Saskatchewan 4-H Lottery #23

Rules of Play

The Saskatchewan 4-H Lottery is administered by 4-H Saskatchewan.
More information is available at www.4-h.sk.ca, by calling 306-933-7727.

1. The draw date is August 21, 2019 @ 1:00 pm in Saskatoon, at the Saskatchewan 4-H Office located at 3830 Thatcher Ave.
2. Tickets can be purchased from participating 4-H clubs or District 4-H Councils, participating prize donor locations, or from 4-H Saskatchewan by calling 306-933-7727.
3. All purchasers must be 18 years of age. Tickets cannot be purchased in the name of a minor.
4. All purchasers must be residents of Saskatchewan. All ticket sales shall take place in Saskatchewan.
5. Only 20,000 Lottery tickets will be sold at the price of \$5.00 each. All tickets are eligible to win a prize. Ticket stubs are placed in a draw drum and the winner determined by the random selection of stubs in the drum. These tickets are returned after each draw to allow equal opportunity to participate in all draws.
6. Only 20,000 add on 50/50 tickets will be sold at the price of \$2.00 each. To be eligible to purchase a 50/50 draw ticket, the purchaser must also purchase One Saskatchewan 4-H Lottery Raffle ticket. You must purchase one Lottery ticket for each 50/50 ticket. 50/50 Ticket stubs are placed in a separate draw drum from the raffle tickets and only one winner is determined by the random selection of stubs from the drum.
7. The ticket sales deadline is July 20, 2019. All tickets and proceeds are to be returned to the 4-H office by this date. Section 3 (d) (III) of the Raffle Terms and conditions requires that all raffle ticket stubs, sold and unsold, and money are returned to the organization prior to any draw taking place.
8. Proceeds for each fully sold book are a 60/40 split. A fully sold book does not include the 50/50 add on, just the Lottery portion of the ticket. 60% will return to the club. The other 40% supports 4-H Provincial programming and resources.
9. Prizes will awarded on behalf of the person named on the ticket. If the winning ticket has more than one name on it, the prize will be awarded to the first name listed on the ticket application. The Saskatchewan 4-H Council is not responsible for any disputes arising between individuals whose names appear on the ticket.
10. Prize winners will be notified in writing or by telephone by 4-H Saskatchewan with information on what they have won and how to claim their prize. A list of winners will be posted on 4-H Saskatchewan's website.
11. Prizes awarded may not be exactly as illustrated. Total retail value of all prizes is approximate based on agreements with prize donors. Cash may not be substituted for prizes unless otherwise stated. No exchanges, refunds or returns.

12. All unclaimed prizes are held for one year after the draw date. If the prizes go unclaimed beyond their hold date, the cash/prize shall be donated to a charitable organization approved by SLGA.
13. Personal information collected will be used to fulfill ticket orders, provide information on our future lotteries or fundraisers, contact prize winners and publicize the names of prize winners. 14. The ticket stub is the official receipt of purchase.
